OFFICIAL BOXING CONTRACT

ARTICLES OF AGREEMENT

This agreement, made and entered into in this 24th day of June, 2025, in Osaka Japan No _____
 by and between Kameda Promotion duly licensed PROMOTER, with postal address at Japan and
Connrad Sseruyange (boxer) a duly licensed BOXER, with postal address at Uganda

WITNESSETH: In consideration of the mutual covenants and agreements hereinafter contained, the parties hereto agree to and with each other as follows:

- That the BOXER will appear and enter into a boxing contest at KYRGYSTAN, Bishkek Arena on the 20 day of July, 2025, or on the other date both parties hereto agree with, for 6 rounds against Munarbek Seitbek uulu (opponent) Pro debut fight, at a weight of not more than 135 pound maxim
- That the PROMOTER will pay the BOXER the sum of US\$ 2000.00 Tow Thouthand doller (SAY. USD) NET RECEIPT. NO DEDUCTION PLANE TICKETS: (2) BETWEEN Uganda - kyrgystan ROUND-TRIP, ECONOMY FOOD AND ACCOMMODATIONS: The Promoter shall pay 2 (Tow) round-trip Air-Ticket's, Hotel and 3 times a meal a day.
- That if the contest is postponed beyond two (2) weeks with the approval of the JBC and _____ and the BOXER elects to honor his commitments he shall not be entitled to receive any additional amount except that provided herein. Should the BOXER chooses not to continue with the contest as postponed, he shall notify the PROMOTER immediately after being so informed, in such case, he shall reimburse any amount he may have received by Virtue of this contract, unless his withdrawal is justifiable.
- That the BOXER agrees to report for physical examination and to appear when and as directed by the PROMOTER or the JBC and U.B.C at all reasonable times for publicity purposes before the contest. The BOXER agrees to present a medical certificate and is not concealing an illness or injury.
- That the BOXER shall have to observe the JBC rules on the weigh-in as follows:
 - If the BOXER should be over the contract weight by more than 3% (Three Percent) at the first weigh-in, he shall not be allowed to make a second weigh-in for safety and shall not participate in the contracted boxing contest.
 - If the BOXER should be overweight by less than 3% (Three Percent) of the contract weight, he shall be given additional two (2) hours to make the weight. If the BOXER should be overweight at the reweigh-in after two hours, the JBC shall not basically allow him to participate in the contest. However, if the JBC should allow the BOXER to participate in the contest, he will be mandated to make reweigh-in on the fight day, if the JBC shall be overweight by more than 8% (Eight Percent) of the contract weight, he shall not be allowed to participate in the contest. If he should be still overweight by less than 8% (Eight Percent) of the contract weight, he shall be allowed to fight as contracted, but shall have to pay the penalty of 25% (Twenty-Five percent) of the contracted purse. Should the BOXER fail to make the contract weight and the contest should be cancelled, he and his manager/representative shall have to pay back the all the necessary expenses including airfare, hotel accommodations, etc.
- That the BOXER shall not enter inter, another contest prior to the one herein contracted once this contract is signed and registered with the JBC except the case approved by the written and signed form of the PROMOTER and the JBC.
- That the contest shall be to a decision as determined under the rules and regulations in effect and within the jurisdiction in which it shall be staged.
- That this contract shall be effective upon registration with, and approval by the U.B.C and the JBC.
- That both parties hereto agree with that the JBC is not responsible to any damage or loss produced by the contest made and entered into by this contract.

1. That the BOXER will appear and enter into a boxing contest at KYRGYSTAN, Bishkek Arena,
on the 20 day of July, 2025 or on the other date both parties hereto agree with, for
6 rounds against Ikhtiyor Nishonov (opponent) Pro debut fight.
at a weight of not more than 154.32 pound, 70.0 kg maximum
2. That the PROMOTER will pay the BOXER the sum of USD 2000,00 Tow Thousand dollar
(SAY: USD) NET RECEIPT. NO DEDUCTION
PLANE TICKETS: (2) BETWEEN Uganda: kyrgystan ROUND-TRIP, ECONOMY FOOD, AND
ACCOMMODATIONS: The Promoter shall pay 2 (Tow) round-trip Air-Tickets, Hotel and
3. That if the contest is postponed beyond two (2) weeks with the approval of the JBC and U.B.C. and the BOXER elects
